David Domenick Jr holds an insurance license to sell insurance products and is the Managing Member of Capital A Insurance, LLC, an affiliated licensed insurance agency. It is anticipated that a small portion, less than (10%) of his time, will be spent providing these insurance products. He will receive compensation from selling insurance products and therefore receive economic benefit for this activity. This activity may create a conflict of interests with clients. The client is under no obligation to purchase insurance through David Domenick Jr on a commissionable basis. To address this, disclosure is made to the client at the time purchase is made, identifying the nature of the transaction or relationship, the role to be played and any compensation to be paid by the client and/or received by the insurance agent. receive any other compensation.
